**Exceptions:** annex III of the RoHS Directive allows exceptions from the restrictions, which are specified in Article 4 and Annex II. Exception 6c provides for a possible lead content by weight up to 4% for copper alloys. BONOMI INDUSTRIES SRL valves, which are made of brass, have a maximum lead content of 2% and therefore comply with the Directive.
